For legal entities and customers where the business relationship for regulatory reasons requires increased surveillance, a surcharge of CHF 500 per quarter will be applied.

**Conditions**  
All prices are excluding VAT and potential external fees (e.g. stock exchange fees, stamp duties). Custody fees are based on the daily average valuation of the last quarter and are charged in arrears at the end of each quarter. Fees are charged per tier (e.g. for CHF 10 m in digital custody: 0.45% on the first 5 m, 0.40% on the remaining 5 m). Fees are charged separately for cryptocurrency trading accounts, cold and hot wallets. Transfer requests from cold wallets will be processed within 3-6 hours Mo – Fr 8am – 3pm CET, excluding bank holidays (of Zug, Switzerland). Requests received after 3pm will be processed next business day. Deliveries into or out of AMINA are only possible to a wallet under the control of the client. Withdrawal fee is charged only once for multiple transfers within one week. Payment fees quoted in CHF are charged in account currency equivalent.
